Status as on 25.10.2021:

This is to inform you that since the Corporate Insolvency and Resolution Process of DHFL has been concluded, the access of documents on Virtual Data Room (Smart Room) will be discontinued from 29.10.2021.

The settlement of claims of NCD and FD holders of DHFL, as per order dt. 07.06.2021 Hon. NCLT has been calculated by Advisors of Committee of Creditors. Status as on 29.09.2021

DHFL – Settlement of claims

The process of implementation of the resolution plan approved by Hon. NCLT as per its order of 07.06.2021 has started. Catalyst Trusteeship Ltd. has been appointed as Global Escrow Trustee to hold on trust, the settlement amount, in form of cash and debentures issued by Piramal Capital Housing Finance Company Ltd. (**PCHFL**) and to arrange for payments to claimants, as per the said approved resolution plan, including to the debenture holders as on 13.08.2021 and the FD holders.

NCD Holders:

The settlement consideration payable to debenture holders are aggregated PAN wise under each series. The amounts payable by cash is being credited to the Bank Account of first holder and payable by way of debentures issued by PCHFL, are being credited to the D-mat accounts of the first holder, as appearing in list of debenture holders as on 13.08.2021.

FD Holders:

The amount payable to FD holders, are being made by crediting to their respective Bank Accounts, as per details made available by DHFL. However, in respect of those FD holders, whose Bank account details are not available with DHFL, are being paid by way of Demand Draft drawn on HDFC Bank Ltd. and being sent to their registered address, by Speed Post.

Status as on 25.05.2021

The appeal filed by Union Bank of India on behalf of the Committee of Creditors ("CoC") of DHFL against the orders dated May 19, 2021 passed by the Hon'ble NCLT were listed before the National







Company Law Appellate Tribunal ("NCLAT") today and NCLAT passed an order in the said matter. Copy of said order has been placed on SmartRoom (VDR) for perusal of Debenture holders.

NCLAT has stayed both the orders dated 19.05.2021 of NCLT. It is further stated that pendency of appeal will not be an impediment for approval of Resolution Plan.

Status as on 24.05.2021

Mr. Kapil Wadhawan, Promoter of DHFL had filed an application with NCLT, Mumbai stating that his settlement proposals submitted vide letters dated 13.12.2020 and 29.12.2020 were not considered by CoC and sought directions to Administrator / COC to consider the same.

Hon. NCLT passed an order on 19.05.2021 directing Administrator to place the settlement proposal dated 29.12.2020 before COC for its consideration and to inform outcome of the same within 10 days. Said order is available on the NCLT website at https://www.nclt.gov.in/interim-order/103584.

On 23.05.2021 Administrator, DHFL has filed an Appeal before the NCLAT against the said order NCLT. The respondents in the said matter are Mr. Kapil Wadhwan, CoC, RBI and Piramal Capital (RA). An application for stay of the said Order of NCLT is also filed alongwith the Appeal. The said letters of Mr. Wadhawan, the Order dated 19.05.2021 of NCLT and a copy of the Appeal filed by Administrator has been placed on VDR, for perusal by Debenture Holders.

The matter was also discussed by majority of COC members with both Legal Advisors of COC and Senior Counsel who appears on behalf of COC in most of the matters at NCLT. Based thereon, an Appeal has been filed by Union Bank of India, on behalf of COC on 24.05.2021, a copy of which is also placed on VDR.

Status as on 31.03.2021

Catalyst has filed an Interlocutory Application No.662/2021 with Hon'ble NCLT, Mumbai on 16th March, 2021 under Section 60(5) of IBC, in the matter of Company Petition No.4258/2019 filed by RBI against DHFL, to decide on the following issues arising out of the resolution plan vis-à-vis distribution mechanism and presently under consideration of Hon. NCLT.

i) Entitlement over Rs.473.82 Cr. presently earmarked for distribution to Fixed Deposit Holder;

ii) Entitlement of debenture holders, over Rs.1170 Cr. presently earmarked as Debenture Redemption Reserve.

iii) To decide on the date of BENPOS for entitlement of NCD holders for the payment as per resolution plan.

Representation by Catalyst in meetings of Committee of Creditors:

As reported earlier through this Status Report, proceedings under IBC are in progress. As a part of it, Administrator is holding meetings of Committee of Creditors **(COC)** and so far one meeting is held 30.12.2019 and 2nd meeting is proposed on 16.01.2020.

As per Section 21(6A) of the Insolvency and Bankruptcy Code, 2016 ("**Code**"), in respect of debentures issued by DHFL, Catalyst, being the Debenture Trustee (**DT**) has to attend the meetings of COC and vote on behalf of debenture holders under each Series. Section 238 of Code provides that the provisions of the Code shall have over-riding effect, on any other law and debenture trust deed. As per Section 25-A of Code, DT has to cast vote on behalf of debenture holders (**DHs**) in accordance with the decision taken by a vote of more than fifty per cent under each Series, who have cast their vote on principle of 'present and voted'. The DT in turn will vote on the basis of the directions of the DHs.

Considering the various provisions of the Code and Rules thereunder, following procedure is being followed.

1. The meetings of COC will be attended by senior officials of Catalyst alongwith experts in financial sector. Apart from the same, representatives of Cyril Amarchand Mangaldas (CAM), Legal Advisors for members of COC, including DT, will also attend the meetings. Further, Administrator has allowed representatives from different sections of financial sector like insurance, banks, mutual fund, PF, to attend COC meetings as invitees, to have benefit of their views during discussion.

2. The notice and minutes of each meeting of COC is shared with DHs through the VDR facility, on their e-mail IDs recorded in the list of DHs (BENPOS).

VERY IMPORTANT AND URGENT

We solicit your immediate attention to your investments in debentures of Dewan Housing Corporation Ltd. (DHFL). It is observed from the latest data of Beneficiary Owners Position (BENPOS) provided the by Registrar and Transfer Agents (RTA) of the related issues that e-mail address connected to the said investments in respect of some Debenture Holders, is **NOT MENTIONED** therein. In this connection, we state:

01. As per provisions of IBC (Regulation 16-A (9 and 25(5, 6) of IBBI CIRP) Regulations), the e-voting window should be open for a minimum of 12 hours. **The aforesaid schedule does not recognize intervening weekly offs or holidays**. It is therefore emphasized the utmost importance of recording of e-mail address in the BENPOS, for proper and effective casting votes by Debenture Trustee on behalf of debenture holders, in the aforesaid strict time schedule.

02. In terms of the Insolvency and Bankruptcy Board of India (Insolvency Professionals) Regulations, 2016 (Rule 7 Code of Conduct), all communications relating to the proceedings of the CoC are to be restricted to debenture holders only and are to be held confidential. Hence, the communications can be sent only to e-mail ID as recorded in the BENPOS. Your attention is invited to Rule 20(7) of IBBI (CIRP) Regulations, 2016 which is as follows:

In response to the Public Announcement dated 04.12.2019 of Administrator / Resolution Professional for DHFL, CTL has filed claims on 16.12.2019, in respect of each of debenture issues / series (total 34). The said claims are made in prescribed Form-C, in capacity as Debenture Trustee, as per the provisions of Section 7 read with Section 21 (6A) (a) of Insolvency and Bankruptcy Code, 2016, in respect of debentures only. While calculating the claims, amount of NCDs outstanding under each ISIN / Series, interest at coupon rate, penal interest / default interest etc. as per Term Sheet, has been taken into account.

In view of the same, we reiterate, there is no need for debenture-holders to file separate claim from their end.

Status as on 05.12.2019:

Reserve Bank of India (RBI) has filed petition on 29.11.2019 with NCLT, Mumbai for initiation of corporate insolvency resolution process against Dewan Housing Finance Corporation Ltd. (DHFL). NCLT has passed an order dated 03.12.2019 admitting the petition of RBI and appointed Mr. R. Subramaniakumar, as an Administrator to perform all the functions of Resolution Professional.

Upon admission of the said petition, as per provisions of Section 14 of Insolvency and Bankruptcy Code, 2016 (IBC) institution of any suit or continuation of proceedings shall be prohibited, as also transferring, alienating or disposing of any assets by DHFL has been debarred.

As per provisions of IBC, Administrator has made public announcement on 05.12.2019 to call for the admission of Claims from the creditors of DHFL on or before 17.12.2019.

Catalyst Trusteeship Ltd. (CTL) is Debenture Trustee in respect of 34 issues of Listed Secured / Unsecured Non-Convertible Debentures (NCDs) issued by way of privately placed as well as public issues, from time. The status of action taken so far in respect of these NCD issues is as follows:

(A) In respect of 14 privately placed issues, debenture-holders had opted for resolution as per guidelines of RBI dt. 07.06.2019. As such, no action of filing of suit with DRT was taken so far.

(B) In respect of 3 public issues, CTL has filed suit with Debt Recovery Tribunal-1, Mumbai (DRT) on 16.10.2019

(C) In respect of 6 privately placed issues, CTL has filed suit with DRT on 08.11.2019.





(D) In respect of 1 privately placed issue, debenture-holders have advised CTL to defer filing of an application with DRT for recovery of dues / enforcement of security.

(E) In respect of 10 Unsecured privately placed NCDs, CTL has issued the notices of demand to DHFL on 22.11.2019 and filing of suit with DRT was proposed to be filed after expiry of notice period.

In response to the Public Announcement dt. 04.12.2019 of Administrator, following action is being taken by CTL:

1. The claim in respect of each of the Series (total 34 Series) will be filed with Administrator, well within the stipulated time. While calculating the claim amount of NCDs outstanding under each Series, interest at coupon rate, penal interest / default interest etc. as per Term Sheet will be taken into account. In view of the same and also as per provisions of Section 21(6A) of IBC, there is no need for individual debenture-holders to file separate claim with Administrator.

2. Further steps will be taken as per provisions of IBC and Rules thereunder as Debenture Trustee from time to time.

For developments in the matter, debenture-holders are requested to visit websites of CTL, DHFL, NCLT and IBBI.

Ministry of Corporate Affairs, Govt. of India vide its Notification of 18th November, 2019, has notified that Reserve Bank of India (**RBI**) shall be the 'Appropriate Regulator' in respect of NBFCs, including HFCs, with assets more than Rs.500.00 cr., under the provisions of Section 227 of Insolvency and Bankruptcy Code, 2016 read with Insolvency and Bankruptcy (Insolvency and Liquidation Proceedings of Financial Service Providers and application to Adjudicating Authority) Rules, 2019.

RBI, in its press release of 20th November, 2019, has stated that it has superseded the Board of Directors of DHFL and appointed Mr. R. Subramaniakumar, Ex-MD and CEO of Indian Overseas Bank, as its 'Administrator' with immediate effect, under Section 45-IE of RBI Act, 1934. RBI has further stated that it intends to shortly initiate the process of resolution of the company under







provisions of Insolvency and Bankruptcy (Insolvency and Liquidation Proceedings of Financial Service Providers and application to Adjudicating Authority) Rules, 2019 and apply to NCLT for appointing the Administrator as the Insolvency Resolution Professional.
