(C) Importance of voting on resolutions:

1. It is absolutely important for the debenture holders to vote on respective resolutions. If they are in favour of the resolution, they may vote as "Assent" and if not in favour of resolution, then as "Dissent". Please note

that as per the views expressed by COC Legal Counsel viz. Shardul Amarchand Mangaldas (SAM), in case the debenture holders who do not vote either as "Assent" or "Dissent" i.e. remain absent from voting, such debenture holders will be considered as "Dissenting Financial Creditor".

2. In case of the 'secured debentures', if the majority of debenture holders under the debenture trust deed relating to a particular issue, vote as "Assent" in respect of the resolution plan, all debenture holders under that secured issue, will get proportionate amount based on their respective admitted claim as per the resolution plan finally approved by all financial creditors.

In case of the 'secured debentures', if the majority of debenture holders under the debenture trust deed relating to a particular issue, vote as "Dissent" in respect of the resolution plan, all debenture holders under that particular secured issue, will get proportionate amount of liquidation value as worked out by the Administrator's Team. Accordingly, the proportionate Liquidation value will be distributed.

3. In case of 'unsecured debentures', if the majority of debenture holders under the debenture trust deed relating to a particular issue, vote as "Assent" in respect of the resolution plan, all debenture holders under that unsecured issue, may get 5% of the admitted claim, if the distribution mechanism is approved by COC.

4. Again, in case of the 'unsecured debentures', if the majority of debenture holders under the debenture trust deed relating to a particular issue, vote as "Dissent" in respect of the resolution plan, all debenture holders under that unsecured issue, may not get anything since the liquidation value for unsecured financial creditors is considered as "Nil".





Hon'ble National Company Law Tribunal, Kolkata Bench vide its order no. C.P. (IB) No. 294/2021 and C.P. (IB) No. 295/KB/2021 dated October 08, 2021 had passed an order for commencement of Insolvency under section 227 read with section 239(2)(zk) of the Insolvency and Bankruptcy Code, 2016 read with rules 5 and 6 of the Insolvency and Bankruptcy (Insolvency and Liquidation Proceedings of Financial Service Providers and Application to Adjudication Authority) Rules, 2019 against SEFL and SIFL.

On last hearing date i.e. September 20, 2021, due to insufficiency of time, our matter could not be reached on board, hence the matter got adjourned to 25th October, 2021.
