In response to the Public Announcement dated 20.02.2025 of Administrator / Resolution Professional for AVIOM, following action is being taken by CTL:

The claim in respect of each series of NCDs will be filed with Administrator, well within the stipulated time. While calculating the claim amount of NCDs outstanding under each Series of NCDs, interest at coupon rate, penal interest / default interest etc. as per Term Sheet/ Transaction Documents will be considered. In view of the same and as per provisions of Section 21(6A) of IBC, there is no need for individual debenture-holders to file separate claim with Administrator.

RBI has filed CIRP petition with NCLT, Delhi. RBI issued Press Release dated 30.01.2025 stating that it has constituted a three-member advisory Committee to assist the Administrator in discharge of his duties.

The members of the Advisory Committee are Paritosh Tripathi (ex-CGM, State Bank of India), Rajneesh Sharma (ex-CGM, Bank of Baroda), and Sanjaya Gupta (ex-MD & CEO, PNB Housing Finance).

Upon admission of the said petition, as per provisions of Section 14 of Insolvency and Bankruptcy Code, 2016 (IBC) institution of any suit or continuation of proceedings shall be



prohibited, as also transferring, alienating or disposing of any assets by AVIOM has been debarred.

This situation has triggered the provisions of the cross-default clause under the DTDs of various ISINs for which we are acting as debenture trustee and issued notice dated 29.11.2024 along with agenda to debenture holders of respective listed and unlisted ISIN informing cross default.

This refers to the Non-Convertible Debentures (NCDs) issued by Aviom India Housing Finance Ltd. (Issuer) for which Catalyst Trusteeship Limited (CATALYST) is acting as debenture trustee. We find that you are the debenture holder of the said NCDs. By letter dated 22.11.2024 Company has disclosed significant developments to BSE including (i) receipt of notices from its statutory auditors, highlighting concerns regarding potential discrepancies in the Company's accounts, (ii) reporting of fraud within the Company, with necessary filings made to the National Housing Bank (NHB) and a complaint lodged with the Economic Offences Wing (EOW), and (iii) liquidity challenges leading to an expected delay in interest payments

Catalyst Trusteeship became aware of aforesaid BSE intimation by issuer on November 26, 2024, and promptly initiated a review of it to assess the implications and determine the necessary course of action. Press release dated November 26, 2024 has been put on our CATALYST website for the information of debenture holders.
