							11. On 16.04.2026 mediation process went ahead. Mediator has asked Issuer to provide some additional information. Next session was scheduled to be held on 11.05.2026. 12. The mediation proceedings were held on 11.05.2026, wherein it was informed to the Mediator that PDL has been admitted into CIRP and, accordingly, the mediation proceedings cannot continue. The counsel for PDL did not appear. The matter has been adjourned to 25.06.2026, and the Mediator may issue notice to the IRP appointed by the Hon'ble NCLT. 13. The Section 7 petition against PEDPL was listed on 21.07.2026. The Hon'ble Bench sought clarification regarding the status of PEDPL as a group company of PDL, which is presently undergoing CIRP.
